TO ALL MOORING PERMIT APPLICANTS: Per Maine State Law, mooring balls MUST be white with a horizontal blue stripe. A current year's sticker issued by the Town of Naples showing the assigned mooring number must be displayed. The sticker must be viewable from a boat, and all old stickers must be removed or covered by the current sticker. A mooring must comply with the Town of Naples Mooring & Waterfront Ordinance Section 6. All moorings are subject to yearly review and inspection. Non-complying moorings are subject to removal at the owner's expense. **Renewals must be received by June 1st of the current year.** After that date, you will be required to pay a late fee of \$15.00. Fees continue to accrue. **Permit stickers will be mailed by June 30<sup>th</sup> of the current year.**
